## **Tender Process**

- In order to ensure equal treatment of all tenderers, the procedure for collecting tenders is managed by the Notary Office Dragica Papež, Opekarska 5, 1000 Ljubljana.
- 2. A tender must be sent in an envelope, by registered mail with a return receipt to the address of the Notary's Office that conducts the procedure for collecting tenders. The offers must be hand signed by the tenderers. If the offer is not sent in the prescribed manner, if there is no handwritten signature and is not accompanied by a proof of payment of the security deposit, it will not be included in the tender process.
- 3. The tenderer may submit more than one tender for each property. For each submitted tender, the tenderer must deposit a security deposit to the fiduciary account of the notary, as specified in the Offer to Purchase, in the amount of EUR 1,000.
  - If, on the basis of the most favourable tender, the tenderer does not conclude a contract within the deadlines set out below, from the Seller's notice that his tender is the highest and is called upon to conclude a contract, the Seller shall withhold the security deposit. Upon conclusion of the contract, the security deposit shall be included in the purchase price.
- 4. Offered price is the criterion for selecting the most favourable tender. If the Notary Office receives several suitable and complete offers with the same offered price for the same real estate, the best tender is the one that has an earlier date and time stated on the return receipt.
- 5. The call for tenders will take place from 7 May until 11 May 2018.

The Seller will send notices on the selection of the most favourable offers from 14 May until 19 May 2018.

The selected tenderers will be invited to conclude contracts from 21 May to 15 June 2018.

Security deposits for tenders, which will not be selected, will be returned to the tenderers no later than 30 June 2018. Security deposits are not subject to interest.
